The Town of Delafield will accept sealed bids for the 2018 ROAD IMPROVEMENT PROGRAM project until **11:00 A.M., Friday, May 22, 2018** at the office of the Town Clerk, Town of Delafield, W302 N1254 Maple Avenue, Delafield, WI 53018. At that time, Town officials will publicly open and read aloud the bids. Normal Town Hall business hours are 8:00 a.m. to 4:00 p.m. Monday through Friday.

Bid Security in the form of a certified check payable to the Town of Delafield or a Bid Bond without condition to the Town of Delafield in the amount of five (5) percent of the base bid shall be submitted with the bid as a guarantee that if the bid is accepted, a proper contract and bond will be executed and filed within 10 days after the acceptance of the bid. If such bidder fails to execute and file such contract, the amount of the check or bid bond shall be forfeited as liquidated damages.

Bids shall be submitted on the bid form provided and all blanks must be filled in for the bid to be accepted. No bid may be withdrawn for a period of 60 days from the date of the bid opening.

All bidders must file a "Bidders Qualification Statement," with the Town Clerk on or before 4:00 pm on Thursday, May 17, 2018 (unless already submitted for 2018).

The Town has the right to reject any and/or all bids received, to waive any minor defects or irregularities that may be found in the bids, and to accept the bid that is in the best interest of the Town.
