Residential PUD's - The general consensus of the Plan Commission is to allow the ability to rezone out of the A-1 PUD zoning district to A-2 PUD zoning district (per Section 18.16 of the Town Code), 5 acre minimum lot size and waive common open space; change the current 120,000 s.f. density factor for A-2 to 3.5 acres (referenced in Table 18-1); and change the current 78,000 s.f. density factor in the A-3 PUD zoning district to 2.75 acres (referenced in Table 18-1), subject to staff review.

Engineer Barbeau was directed to provide a red-lined version of the suggested changes for review at the next meeting. An anticipated Public Hearing will be held in front of the Town Board in August.
