Section 19 – Modify the language in 17.05 5.A.2.a. to change "3 acres" to "5 acres."

Section 19 - Modify the language in 17.05 5.C.2.f. and 17.05 D.2.h. to add the following sentence at the end of the first paragraph: "No use shall be approved unless the applicant implements the conclusions and recommendations of the study."; also repair numbering format.

Section 19 – Modify the language in 17.05 5. D. 2. K. to remove the word "day" and replace with the word "week."
