A. Consideration and possible action on an Ordinance to Amend the Zoning Map, Joseph Gliniecki, W300S1350 Brandybrook Rd.

Engineer Barbeau stated that the subject property is surrounded by Waukesha County shoreland zoning, but the location of the home is in the Town's A-1 zoning district. Currently, the subject property does not meet the required 95% open space and is considered a legal non-conforming lot. The request to rezone to A-2 Rural Home District will reduce the open space requirement to 85% and will allow the lot to become conforming.

Engineer Barbeau summarized the subject request to take off the existing 6' roof of the garage at the subject address and increase it to 8' to allow regular sized vehicles to park in the structure. Since the property is located within the County Shoreland zoning, the property owner requested a permit from Waukesha County. The Ordinance of the County Shoreland requires that all improvements within a Town right-of-way be approved by the Town Board.
