Supervisor Mahoney-Ogden explained she did some research on how this came to be. The statute was said to be put in place to protect property owner's rights. She explained the Town does not need to be in compliance with state statutes until 2025. She explained the Town has only used this provision in the Town Code for the Thomas Farm, and no other time. By passing this now, the board would be taking people's right to protest away early. Out of principal Supervisor Mahoney-Ogden stated she would like to wait until the

summer to take up this ordinance. She also stated the main reason for the Town taking this ordinance up now is, so it was not forgotten about.

Supervisor Woelfle stated when we are given a recommendation about something by our attorney, it is to prevent the Town from being sued. He is concerned about the timeframe of not following the state statutes.

Motion By Supervisor Mahoney-Ogden to defer "Discussion and possible action on the recommendation from Plan Commission to adopt Ordinance 2023-09, an ordinance to repeal Section 17.10 5H of the municipal code relating to protests of zoning code changes or amendments" to a July meeting. Seconded by Supervisor Michels. Motion passed 4-1, with Supervisor Woelfle opposing.

RE: Discussion and possible action on the capital improvement schedule and purchase of a wheel loader for the Highway Department.

Description

In 2022 the Town Board approved the purchase of two new plow trucks with the use of ARPA funds. These trucks have been delayed due to manufacturing delays. The first chassis was completed later this year and is currently being outfitted by Burk Truck. We anticipate this truck to be available in the early part of 2024. The second chassis, however, still has not been built, and we are seeing various dates for completion ranging from March to late in the year of 2024.

The Highway Department currently uses their wheel loader both to load salt, and as a snowplow. Superintendent Roberts has discussed purchasing a second wheel loader to be used as a plow truck. With the shortage of equipment in general, including trucks and loaders, we are trying to take advantage of any way to obtain vehicles for the fleet. A loader was located for a great price. Staff has asked the board to consider the purchase of a Volvo L70H Wheel Loader as described in the quote from Arina Equipment for a price of \$208,000, and an additional \$6,000 to be outfitted with appropriate snow tires.

Town staff would still like the International truck chassis to remain on order. If the chassis becomes available in 2024, we will outfit that truck to be part of the fleet as well. The cost for a chassis and build is anticipated to be \$250,000. Based on the schedule of equipment replacement, this purchase would alleviate any major equipment purchases for at least 4 years. This would leave the 2006 Sterling as the oldest major equipment replacement, which is anticipated to last until 2028/2029.

Fiscal Impact

Currently the Town has \$337,501.53 in the ARPA account. The anticipated cost to finish the truck at Burk (anticipated to be complete in January), is \$73,000. The cost of the loader and wheels will be \$214,000. The anticipated ARPA funds remaining after these purchases is \$50,500. The Town also has a replacement balance budget of \$72,500 by year end 2024. The replacement fund reserves along with the ARPA funds remaining will provide \$123,000 toward the new vehicle purchase. The 1999 and 2001 Sterling plow trucks would be auctioned and would anticipate a revenue between \$30,000 and \$35,000. The remaining funds for the anticipated \$250,000 truck purchase would be utilized in general fund reserves for the remainder of the purchase. This would require roughly \$95,000 in reserve funds, which we would anticipate replenishing over the next four years, as we will have no equipment replacement during that time.

Recommendation

At this time, the staff is looking for guidance from the board as to whether they would approve utilizing general fund reserves for capital equipment. I have attached to this memo a vehicle replacement schedule that outlines all capital equipment in the fleet. It also gives recommended replacement dates and estimated costs for each. Utilizing general fund reserves is a policy decision, and not one that staff can give a recommendation.
