

ORDINANCE NO. 2006.006

AN ORDINANCE TO REVISE CERTAIN PROVISIONS OF THE TOWN OF DELAFIELD CODE

WHEREAS, the Town’s municipal prosecutor has reviewed the Town’s existing Code and has made recommendations regarding outdated, duplicate or unnecessary regulations; and,

WHEREAS, the Town Board has determined that it is necessary to adopt some of the recommendations to update the Town’s Code.

NOW, THEREFORE, the Town Board for the Town of Delafield, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1:

Section 7.04, entitled “Keys in Motorcycles and Automobiles”, shall be repealed in its entirety.

SECTION 2:

Section 9.11, entitled “Vicious Animals”, shall be repealed in its entirety.

SECTION 3:

Section 9.01, entitled “Offenses Against State Laws Subject to Forfeiture”, shall be amended as follows:

(a) to reflect current state statute numbers and reorganized as necessary

- 9.254.76 Careless Smoking
- 9.285.30 Tampering with Pollution System
- 9.961.14(3) Possession of Controlled Substance
- 9.961.41(2m) Manufacture/Delivery of Controlled Substance
- 9.218.0145 & 9.218.0146 Used Cars/Prohibited Acts
- 9.218.0147 Motor Vehicles/Sales to Minors

(b) to repeal

- 9.943.22 “Use of Cheating Tokens”

(c) to adopt

- 9.940.32 Stalking
- 9.941.237 Possession of Handguns in Taverns
- 9.941.26(4) Use of Pepper Spay
- 9.944.32 Soliciting Prostitutes
- 9.944.205 Photos/Videos Showing Nudity
- 9.948.605 Gun-free School Zone


SECTION 4: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable, such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinance whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.


SECTION 5: EFFECTIVE DATE.

This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
