ORDINANCE NO. 2015-10

AN ORDINANCE TO CREATE SECTION 1.31  
ENTITLED PUBLICATION AND POSTING  
OF OFFICIAL PUBLIC NOTICES  
OF THE TOWN OF DELAFIELD TOWN CODE

WHEREAS, 2015 Wisconsin Act 79, which was enacted on November 11, 2015, and became effective on November 13, 2015, grants municipalities the ability to post official notices in one location and on the Town website in circumstances where former laws required posting in three locations; and

WHEREAS, the Town of Delafield Town Clerk has recommended that the Town of Delafield take advantage of this more efficient process that is very likely to reach as many or more Town residences with timely notice of Town affairs; and

WHEREAS, the Town of Delafield Town Board hereby intends to exercise the authority described in 2015 Wisconsin Act 79.

NOW, THEREFORE, the Town Board of the Town of Delafield, Waukesha County, Wisconsin, DOES HEREBY ORDAIN AS FOLLOWS:

SECTION 1: Chapter 1 of the Town of Delafield Municipal Code entitled "General Government," Section 1.31 entitled "Publication and Posting of Official Public Notices," is hereby created as follows:

1.31 Publication and Posting of Official Public Notices.

All ordinances and notices which are to be published shall be published in the newspaper, except in those cases where the Wisconsin Statutes require publication in some other manner or the Wisconsin Statutes permit publication in some other manner. Whenever posting may be used in lieu of publication in a newspaper, posting shall be as described as follows. Pursuant to Wisconsin Statutes Section 985.02(2)(a), the notice may be posted in the front window of the Town Hall located at W302 N1254 Maple Avenue, Delafield, Wisconsin, and placed electronically on the Town's official internet site, in lieu of posting in three locations.

SECTION 2: SEVERABILITY.

The several sections of this ordinance are declared to be severable. If any section or portion thereof shall be declared by a court of competent jurisdiction to be invalid, unlawful or unenforceable,


such decision shall apply only to the specific section or portion thereof directly specified in the decision, and shall not affect the validity of any other provisions, sections or portions thereof of the ordinance. The remainder of the ordinance shall remain in full force and effect. Any other ordinances whose terms are in conflict with the provisions of this ordinance are hereby repealed as to those terms that conflict.

SECTION 3: EFFECTIVE DATE.


This ordinance shall take effect immediately upon passage and posting or publication as provided by law.
