

**TOWN OF DELAFIELD BOARD OF SUPERVISORS MEETING**  
**JUNE 8, 2021 @ 6:30 PM**

**First order of business:** Call to Order

Supervisor Troy called the meeting to order at 6:30 p.m.

**Second order of business:** Pledge of Allegiance

**Third order of business:** Roll Call

Present were: Supervisor Kranick, Supervisor Dionisopoulos, Supervisor Woelfle and Chairperson Troy. Also present was Administrator Dan Green and Town Engineer Tim Barbeau. Supervisor Michels was excused.

**Fourth order of business:** Citizen Comments:

John Miller, N20W29526 East Glen Cove Road, thanked the Town Board for their service to the Town. He asked that when reviewing Town Ordinances, that they do not change the Town's rules for the sake of change, but to improve upon them. He asked that they keep in mind that rules were set in place for a reason.

*Motion made by Supervisor Kranick to approve the minutes from May 24, 2021. Seconded by Supervisor Dionisopoulos. Motion carried 4-0.*

- A. Elmhurst Bridge Reconstruction

Administrator Green updated the board that DOT will be finalizing a bid on June 9<sup>th</sup>, and information regarding the bridge reconstruction will be on the Town's website soon after. Postcards will be sent to neighbors to the north and south of I-94 notifying them of the reconstruction and of an open house scheduled for Tuesday, July 6, 2021, at Town Hall.

- B. Waukesha County RFP for Waste Hauler

The RFP process for a waste hauler through Waukesha County has begun. The County is looking for one representative from each municipality to review the bids and attend meetings throughout the process. The board agreed to have the Town Administrator serve at this role.
