Engineer Barbeau summarized the proposed request stating that the conditions defined in the motion of the 10/11/16 Plan Commission required the existing accessory building to remain on site and a financial guarantee be submitted in the amount of \$16,500. The developer would receive these monies back after a building permit was acquired and work proceeded on lot 14, within two years of recording the final plat. A building permit has been issued, footings have been poured and there is excavation on the site.

B. Consideration and possible action on a request from Anthony Fronczak, S11 W29586 Summit Avenue to approve a request for rezoning on a 48.92 acre property located at S11 W29586 Summit Avenue from A-1 to A-2

MOTION MADE BY MR. KRANICK, SECONDED BY MR. COOLEY TO APPROVE A REQUEST FOR REZONING ON A 48.92 ACRE PROPERTY LOCATED AT S11 W29586 SUMMIT AVENUE FROM A-1 TO A-2 CONDITIONED UPON A DEED RESTRICTION BEING RECORDED SIMULTANEOUSLY WITH THE CSM AND THAT NO OTHER DIVISIONS WILL BE ALLOWED FOR THIS PARCEL OF LAND. MOTION CARRIED.

C. Consideration and possible action on a request from Anthony Fronczak S11 W29586 Summit Avenue for approval of a Certified Survey Map to split a 48.92 acre parcel into two properties

Engineer Barbeau stated that the Plan Commission approved the CSM subject to Staff recommendations and conditions are met (a soil test is required), the driveway easement agreement is presented to the Town Board and the condition stated on the CSM that no further divisions of the parcel are allowed. The owner needs to address the following: an on-site septic inspection and define the use of a shed on the westerly parcel of land. If it is not being used for agriculture at this time, it needs to be removed.

The general consensus of the Town Board is they are not comfortable going forward with this proposal until all loose ends are tied up.

D. Consideration and possible action on a request from Jay T. Stueber N20 W28598 Louis Avenue for approval of a Certified Survey Map to combine three lots of record into one parcel

MOTION MADE BY MR. KRANICK, SECONDED BY MR. COOLEY TO APPROVE A REQUEST FROM JAY T. STEUBER, N20 W28598 LOUIS AVENUE, OF A CERTIFIED SURVEY MAP TO COMBINE THREE LOTS OF RECORD INTO ONE PARCEL. MOTION CARRIED.

E. Consideration and possible action on a request from Iron Pipe Development for approval of a Certified Survey Map to split lands located west of Cushing Park Road, between USH 18 and Abitz Road

Engineer Barbeau stated that the Plan Commission recommended approval of the CSM subject to his Staff recommendations. He directed attention to outbuildings located on the southerly portion of the property and stated the Town's intention to direct that they be removed. The house will be removed, but the developer has stated his request, in writing, to keep the barn. Engineer Barbeau informed the developer that he would need to appear before the Plan Commission and present his proposal.
